NEW GUIDELINES TO RECYCLE ALL BEVERAGE BOTTLES TO SIGNIFICANTLY REDUCE LANDFILL WASTE AND THE IMPACT OF PLASTIC ON THE ENVIRONMENT, ANIMALS AND HUMANS.



PLASTIC BOTTLE RECYCLING CAN BE DONE IN TWO WAYS:

RECYCLE AT THE STORE

- THE PIKADON LAW STATES THAT STORES ARE OBLIGATED TO RECEIVE, STORE AND TRANSPORT BOTTLES OF BEVERAGES THEY SELL AT ANY POINT DURING BUSINESS HOURS.
- THE STORE WILL ONLY ACCEPT BOTTLES FOR RECYCLING THAT THEY ALREADY SELL
- YOU CAN RETURN UP TO 50 BOTTLES PER DAY TO ANY ONE STORE
- YOU WILL RECEIVE EITHER CASH OR CREDIT DEPENDING ON THE POLICY OF THE SPECIFIC STORE



STORING OF BOTTLES

- YOU CAN COMPRESS THE BOTTLES. THIS DOES NOT EFFECT THE RECYCLING PROCESS



REJECTED BOTTLES?

- REFUSAL TO ACCEPT THE BOTTLES AS DESCRIBED ABOVE IS AGAINST THE LAW. YOU CAN REPORT ANY INSTANCE OF THIS AT PIKADON@CONSUMERS.ORG.IL OR BY FILLING IN [THIS FORM](#).

EVEN THOUGH WE CAN NOW DEPOSIT BIG BOTTLES, IT'S STILL IMPORTANT TO REDUCE OUR USE OF SINGLE USE PLASTIC BOTTLES AND SINGLE USE PLASTIC IN GENERAL.

** A BUSINESS LARGER THEN 28SQ METERS WHICH SELLS THE SAME TYPE OF BOTTLES MUST ACCEPT ALL LARGE BOTTLES AS LONG THEY STOCK THAT PARTICULAR BRAND. SMALLER BUSINESS ARE ONLY OBLIGATED TO ACCEPT THE BOTTLES IF THEY ARE THE SAME AS THE ONES THEY ALREADY STOCK.

** THE BOTTLES WILL BE PASSED ON TO THE TAMIR RECYCLING CORPORATION.
